The VFF Egg Producers Group has made the following effective from the Annual General Meeting of Group members held on 8 June 2000:

In addition to any requirements for membership of the Victorian Farmers Federation in place at the time, a requirement of membership of the Group shall be that a member agrees to conform to the Code of Practice for the Welfare of Poultry in effect at the time of application for membership of the Group and as may be amended from time to time during the period of membership.
