The 2021 Study Tour of Victoria will replace the New Zealand Study tour in 2021. Victoria is the dairy heartland of Australia, home to world class farmers, research and production.

The Victorian tour is an exclusive opportunity to find out how dairy and other agricultural industries are building success by utilising new and innovative technologies. Technology is changing the face of food and fibre production around the world. From DairyBio and genomics to GPS cow management, this is the most exciting time to be in dairy.

This tour will give participants an in-depth insight into cutting edge science and practice and how they might adapt new processes and technologies in their dairy operations.

The study tour is organised by United Dairyfarmers of Victoria (UDV) and funded by the Gardiner Dairy Foundation.

The Tour

The selected participants will explore Victoria from the 28th of June until the 6th of July on a fully funded eight day tour. Key activities undertaken during the tour will include:

- Visit leading dairy farms utilising a variety of farm systems and technology;
- Tour dairy research and processing facilities;
- Visit industry stakeholders and learn about industry issues and advocacy work;
- Meet leading industry representatives;
- Meet like-minded young people with a passion for the dairy industry and
- Engage in social and recreational activities.

To apply you need to:

- Be aged between 18-35 years;
- Live and work in Victoria
- Be available for travel between the 28th of June and the 6th of July;
- Actively participate in the dairy industry either on or off-farm;
- Be enrolled in or have completed tertiary studies related to the dairy industry e.g. Certificate II, III, or IV or Bachelor degree; OR proven participation in dairy industry short course(s) such as those run by GippsDairy, Westvic Dairy, Murray Dairy, DEDJTR and others;
- Agree to contribute to dairy industry publicity and promotion with the UDV and Gardiner Dairy Foundation; and
- Continue to build personal leadership skills and undertake leadership roles in the industry and/or community
